In order to ensure the safety of the public, no public use of the fenced in lagoon area will be allowed except by "special" permission of the Unity Utilities District Trustees.

Requests for use must be submitted in writing to the Town Clerk. The Town Clerk will forward the request to the Unity Utilities District Trustees for discussion/decision at the next scheduled meeting.

Should the trustees grant "special" permission, each person using the facility must fill out and have notarized the risk agreement form.

**Release, Covenant Not To Sue,

I, the undersigned Participant, for myself, my heirs, legal representatives and assigns, in consideration of permission granted to me by the Unity Utilities District, located in Unity, Maine, to use the wastewater lagoon area, hereby release, acquit and forever discharge Unity Utilities District, its Trustees, officers, employees and agents, both in their individual capacities and in their capacities as Trustees, officers, employees and agents of Unity Utilities District their heirs, legal representatives, successors and assigns, from any and all claims, demands, actions or causes of action, of any kind whatsoever, including claims for contribution and/or indemnification, arising out of my use of the area (see reverse side).

I, also, for myself and for my heirs, legal representatives and assigns, for the same consideration, covenant with Unity Utilities District, its Trustees, officers, employees and agents, both in their individual capacities and in their capacities as Trustees, officers, employees and agents of Unity Utilities District, their heirs, legal representatives, successors and assigns, never to institute any suit or action at law or in equity against them, or any of them, whether or not the result of their negligence, by reason of any claim I now have or may hereafter acquire relating to said use of the area.

I assume the risk of any injuries which I may receive h, whether or not the result of their negligence.

I also certify that the information I have provided to Unity Utilities District accompanying this release, covenant not to sue, and assumption of risk agreement, is true and accurate and recognize that any false or incorrect statements made therein are grounds for my dismissal from site.
