

Selectmen's Meeting

July 05, 2022

Penny opened the meeting at 6:34pm.

Public Feedback: The boat dock at Kanokolus is crooked. Need to order chain and need to relocate the ground moorings. Dock is tied down with ratchet straps.

Minutes:

Penny made a motion to accept the minutes from 06/21/2022. Tim seconded the motion. Motion carried.

Administrative Assistant/Treasurer:

- Warrants were reviewed and signed by Selectboard.
- Penny made a motion to purchase supplies needed for Anne to work on the Planning Board books.

Old Business:

- Inform the assessor the town voted to accept the quarterly review.
- Dan sent an email to ProSeal with a list of roads and still do not have a price.
- Penny has not been able to successfully get ahold of the company to set the poles for the electronic crosswalk.
- Jean will be at the July 11th meeting to go over the library TIF request.

New Business:

- Dave Huff hit a deer while responding to a complaint about a dog. Sheriff's office was unable to get ahold of Rachael, Unity's ACO. Dan McCormick requested that the Sheriff's office try to get ahold of an ACO from another town that could respond. Dave is seeking \$500 from the town of Unity to help pay for the deductible. Penny made a motion to appoint Dave as a back up ACO at the rate of \$15/hour. Tim seconded the motion. Motion carried. Penny made a motion to table further discussion until legal advice is received. Tim seconded the motion. Motion carried.
- Selectboard would like to put up no trespassing signs and locks at 113 Windemere Ln. Should the town have a professional cleaner come in? Work on putting it out to bid. Dan

made a motion to put 113 Windemere Ln out to bid, as is, with a \$40,000 minimum bid. Tim seconded the motion. Motion carried.

- The old swimming dock is at Kanokolus. Mike Lancaster is working with the Unity Raceway and said they could use a couple sections of the old dock. Penny made a motion to put the dock out to bid, the awarded bidder will be responsible for removal of the dock. Tim seconded the motion. Motion carried.

Swing set was vandalized. Scott, the CBI fixed it the best he could. The swing set is for kids only. Kari will make vinyl labels to put on the swing that say kids only!

- Dan will take a look at the culverts at 208 Stagecoach Rd to see if any repairs need to be done..

- Penny made a motion that due to Ameila passing, she proposed that Amaya be promoted to office dog and Abby deputy office dog. Tim seconded the motion. Motion carried.

- Tim requested that next year, Unity do something for the 4th of July.

- Penny made a motion to enter into executive session pursuant to MRSA 405 6 A for personnel. Tim seconded the motion. Motion carried. Dan asked Blaine to join them.
